# issued by 'Unity Line' ferry lines for ferry links: Świnoujście – Ystad & Ystad – Świnoujście

# Świnoujście – Trelleborg & Trelleborg – Świnoujście

# valid from 1<sup>st</sup> of April 2025 until further notice

# **GENERAL TERMS**

- 1. This freight tariff is applicable for following ferries in 'Unity Line' ferry lines service: m/f Polonia, m/f Skania, m/f Gryf, m/f Epsilon, m/f Galileusz, m/f Copernicus or others announced to the traffic by the Carrier, either for temporary or permanent timetable.
- 2. A cargo ticket shall be issued by the Carrier or other authorized persons as agents in respect of goods.
- 3. The shipper shall be obliged to present goods for a carriage clearance at least 2 (two) hours prior to a departure falling which the Carrier shall have the right to refuse to ship the goods.
- 4. The rates are quoted in EUR (Euro currency) and are net, and do not include any mandatory and/or official and/or statutory charges, fees, duties, taxes and the like. The rates are for a one way trip on the link.
- 5. The rates do not include surcharges provided for in this tariff. Unless otherwise expressly stated in this tariff, the rates do not include stevedoring costs and other services provided by ports, their agents or contractors for goods details of which are available on request from the Carrier.
- 6. The Carrier shall have the right to amend this tariff from time to time without prior notice.
- 7. This tariff is written in the English and Polish languages and in the event of any inconsistency between either version the English language version shall prevail.

In all referred below vehicles (except point 1.4) the freight rate includes passage, berth and two meals for one driver.

1.1. Minimum freight

EUR 70,00 per unit

1.2. Cargo vehicles and buses without passengers

EUR 25,00 per each commenced meter

1.3. Cargo vehicles up to 8 m long (L-car)

EUR 150,00 per unit

1.4. Trailers and caravans, mobile homes without passengers

EUR 22,00 per each commenced meter

1.5. Cranes, agricultural and road construction machines and others

EUR 30,00 per each commenced meter

1.6. For vehicles exceeding one of the following parameters: length more than 26 m; width more than 4 m; height more than 4 m; axle weight more than 7 t, if distance between axles is 1,3 m or less; axle weight more than 10 t, if distance between axles is more than 1,3 m; total weight more than 60 t,

the freight and transport conditions shall be subject to a separate agreement

# 2. Surcharges

## 2.1. Second driver

EUR 70,00 (includes passage, berth and two meals)

# 2.2. Loading

## 2.2.1. Trailers

**EUR 60,00** per unit Loading/discharging on board/ashore of the trailers mentioned in point 1.4.

## 2.2.2. Vehicles without drivers

## EUR 85,00 per unit

Loading/discharging on board/ashore of the vehicles mentioned in point 1 (except 1.4 & 1.7) and 24 hours of storage.

# 2.3. Bunker Environmental Surcharge (BES)

Charged for each commenced meter of the vehicle. The amount of the surcharge is determined by the currently applicable Bunker Environmental Surcharge Announcement published separately (available at: www.unityline.pl). The Carrier is entitled to adjust the amount of the surcharge in the event of changes in the stock exchange fuel prices or significant changes in the obligatory costs of ecological operation of the service in ports and at sea, resulting from the need to adapt to new convention regulations and port tariffs.

## 2.4. ETS

Charged for each commenced meter of the vehicle. The amount of the surcharge is determined by the currently applicable ETS Surcharge Announcement published separately (available at: www.unityline.pl). The Carrier is entitled to adjust the amount of the surcharge on the basis of monthly average  $CO_2$  emissions by all ferries of our service and according to the monthly average price of emission allowances.

# 2.5. Dangerous goods

Please note that not all ferries have a possibility to carry the dangerous goods and the availability of places is limited.

2.5.1. vehicles containing dangerous goods, also including empty but uncleaned vehicles

EUR 85,00 per unit

2.5.2.vehicles containing dangerous goods of class 1.1, 1.2, 1.3, 1.4 and 1.5 of all compability groups except 1.4S, also empty but uncleaned vehicles

EUR 1400,00 per unit

## 2.6. Exceeded standard width

This surcharge has been suspended until further notice.

Not all ferries can transport vehicles with exceeded dimensions (see the table in point 1), and the number of these places is limited. Each transport of a vehicle with an exceeded standard dimensions requires prior inquiry.

## 3. Penalty fees

- 3.1. Fee for not used bookings (no show)
  - 3.1.1. in the case of failure to deliver a vehicle with a confirmed cargo booking (with OK status)

EUR 35,00 per booking

3.1.2. in the case of a cancellation or a change of a confirmed cargo booking (with OK status) in less than 2 hours before the scheduled departure of the ferry

EUR 25,00 per booking

3.2. Fee for transportation of dangerous goods without obligatory declaration or cargo excluded from transportation

EUR 1400,00 per vehicle

The actual cargo fairway dues are included in the rates provided in this tariff.
